#### Standing Judicial Order of the Belchertown District Court regarding Trial Readiness

- All cases scheduled for a jury trial shall also be automatically scheduled for a Trial Readiness Conference (TRC) at 10:00 a.m. on the Wednesday the week before trial.
- The purpose of the Trial Readiness Conference is to determine which cases are expected to actually proceed trial. The goal is to allow attorneys to focus on trial matters and to enable the Court to avoid needlessly bringing in witness and jurors.
- 3. All attorneys with a matter scheduled for trial are required to attend.
- 4. All defendants are required to attend.
- 5. All substantive pre-trial motions must be filed with the court one week in advance of the TRC. Such motions include, but are not limited to, motions to admit excited utterances, motions to admit prior or subsequent bad acts, motions to preclude impeachment with prior convictions, and motions to admit or preclude the admission of any proposed evidence. This does not include boiler-plate motions such as motions to sequester witnesses or to exclude the results of the HGN test.
- 6. In an effort to expedite cases, motions for the appointment of counsel to ascertain 5<sup>th</sup> Amendment rights or marital privileges should be filed and heard at a pretrial conference prior to the TRC. Any witness asserting a privilege will be excused from appearing for trial. This will give the Commonwealth time to decide whether it intends to attempt to proceed with any excited utterances. Motions to admit excited utterances will be heard at the Trial Readiness Conference.
- To determine, prior to trial, whether a witness intends to assert a 5<sup>th</sup> Amendment or marital privilege, either party may summons the witness to a pretrial conference or the TRC. Such summonses must be issued in good faith. Abuse of this process will result in appropriate sanctions.
- The TRC is the last opportunity to execute a jury waiver and request a bench trial. The Court will endeavor to honor the original trial date and schedule the bench trial on that same date, or, if requested, on a different date at the convenience of the parties.
- If the Defendant tenders a plea on the day of trial and it is not accepted by the Court, the case will proceed to trial that day. Defense counsel are encouraged to bring such cases forward to offer a plea prior to the trial date.
  - On the day of trial, the jury trial will take priority. Normally, pleas will be heard after closing and charge.
